
Passengers can carry no more than 20 spare batteries (Spare batteries include unwrapped batteries, such as lithium batteries, non-spillable batteries, nickel-metal hydride batteries and dry batteries; batteries from other battery-powered devices, such as Battery-Powered (Smart) suitcases, removable batteries from Battery-Powered wheelchairs/mobility aids and carry-on power banks) are also included in the 20 spare battery limit.

每位旅客可携带2个100-160wh之间的备用锂电池或充电宝;对于电压≤12V且≤100Wh的密封型电池,每位旅客可携带两块。

Passengers can carry 2 backup lithium batteries or power banks with a capacity between 100wh and 160wh; passengers can carry 2 non-spillable batteries with electric voltage not exceeding 12V and 100Wh.

Passengers must have an ample supply of fully charged batteries plus three hours of extra battery time for the flight.
